Budget 2024-2025: Discussion of staff compensation, FM compensation. Discussion of increasing staffing to 24/7 coverage. We should go out to bid and ask for both a flat rate and a per-storm rate. We can send the RFP to local companies that provide snow removal services. Could we take of snow in house? What does that look like, would we need extra insurance? Could we use money from the fund balance to offset some costs to the taxpayers?

Discussion of what expense could be paid out of the fund balance. Motion to spend \$60,000.00 out of the fund balance to pay for the Chiefs SUV payment \$36,918.00, Knox Box upgrade \$8082.00, and firefighter gear \$15,000.00 Kevin Clynch, John Burnham second. All in favor

The proceeds from the fundraiser will help the family with home renovation to make it more suitable for Gavin. The pasta dinner
